A zoning order contains a set of conditions/requirements that are stipulated through the government to accomodate impacts from either building or expanding a property. Each order is unique and determined by the size of the impact. Modern on M's site plan includes transportation initiatives like unbundling the price of parking, installing a real-time transit display, providing bicycle parking, having an electric car charging station, and offering Capital Bikeshare memberships and/or car-share memberships for all residents.

In addition to all of these solutions, Modern on M has worked with goDCgo to host events to promote the use of sustainable transportation and create an eco-friendly culture for the property. goDCgo has trained their leasing

staff on the alternative travel options in the District, including tips and tricks to help not only current but potential residents as well. DOES YOUR PROPERTY HAVE A ZONING ORDER?

goDCgo provides complimentary assistance to meet your transportation requirements, including sustainable transportation options for residents and people visiting or commuting to your property. Offering sustainable amenities can make your business even more competitive in the marketplace. If you are unsure if your property has a site plan, visit the DC Office of Zoning's official zoning map to search your property's address.

DDOT evaluates the impact of certain development actions on the multi-modal transportation network. The cycle begins when a development triggers a need for review. DDOT and the property owner work together to develop a Transportation Demand Management (TDM) Plan. Then the approval body sets the site conditions, which requires the implementation of certain transportation amenities. During the building phase, goDCgo can support the property owner with completing any preopening site requirements to obtain a Certificate of Occupancy. Once the building is open, goDCgo will continue to support the property by working with the on-site TDM Coordinator to share information with residents.
